### **3. Acquiring Your Marriage License**

A valid BC marriage license must be present at your ceremony. If circumstances prevent this, the Officiant can perform a symbolic ceremony with an option for a private, legally binding ceremony later for an additional fee of \$150.00, subject to availability.

#### 4. Understanding Cancellation and Refunds

Rest assured, your Officiant's commitment to your event is steadfast. We'll strive to find a suitable substitute through our network in extraordinary situations out of our control. If impossible, a full refund is offered. Cancellations by the Client over 30 days before the date are partially refunded, minus a \$150 fee, while deposits remain non-refundable within 30 days of the event.

#### 6. Licensing
